

## Installation Instructions, Fanuc A05B-2490-Series Pendant Armor®:

- 1) Power-down the controller, and disconnect the cable at the rear of the pendant
- 2) Remove the Velcro OEM hand strap and hanger from the pendant (retain screws)
- 3) Place the bumper face up on a clean, dry surface
- 4) Place the pendant atop the bumper and fit into the lower edge of the bumper



- 5) Ensure the hand-strap cam and bottom edge are fully seated into the bumper
- 6) Fit the bumper along both sides and then over the top of the pendant
- 7) Reattach the Velcro hand strap and install enlarged hanger (provided). Reuse screws from step-2
- 8) Note: If your local safety requirements dictate unencumbered or direct access to the E-stop button, cut the protective rubber brow as your safety requirements dictate. A molded cut-line is embossed around the E-Stop brow. A utility knife may be used to cut the Santoprene™
- 9) Reconnect the controller cable on the rear of the pendant, and reset the E-stop
- 10) Power-up the controller
- 11) Installation is complete
