

Pendant Armor® Installation Instructions

KUKA KRC4 smartPAD

1) Power-down the controller, and disconnect the pendant cable from the controller (do not attempt to disconnect the cable from the smartPAD).

2) Place bumper face up on clean dry surface. Pass cable through hole in lower-left corner of the bumper.



3) Fully seat the smartPAD along the lower-edge of the bumper while pulling the cable through the bumper.



4) Pull the top of the bumper over the handle on the rear of the smartPAD. Then fit the right edge around the 6-axis mouse and over the E-stop ridge (top right-corner).

5) Pull the bumper over the left corner.

6) Dry fit the hand-post cap. If you choose to utilize the cap, apply a small (continuous) bead of glue around the inside circumference of the cap, and apply to the smartPAD hand-post. Hold in position for 45-seconds to allow the glue to set.



7) Reconnect the controller cable.

8) Power-up the controller and reset E-stop button.

9) Installation is complete.
