

Pendant Armor® Installation Instructions

KUKA smartPAD2 (Next Gen)

- 1) Power-down the controller and disconnect the pendant cable from the controller (do not attempt to disconnect the cable from the smartPAD).
- 2) Place bumper face up on clean dry surface. Pass pendant cable through hole in lower-left corner of the bumper.



- 3) Fully seat the smartPAD2 along the lower-edge of the bumper while pulling the cable through the bumper.



- 4) Pull the top of the bumper over the hand posts on the rear of the smartPAD. Then fit the right edge around the 6-axis mouse and over the E-stop ridge (top right-corner).
- 5) Fit remaining edges and pull the hand straps through the slots on the left and right sides of the bumper.
- 6) Reconnect the pendant cable to the controller.
- 7) Power-up the controller and reset E-stop button. Installation is complete.
