

Installation Instructions, Universal Robots e-Series Pendant Armor®:

- 1) Power-down the controller
- 2) Place the e-series pendant face up on a clean, dry surface
- 3) Depress the E-Stop button (down position)
- 4) Lay the bumper atop the pendant
- 5) Begin by fitting the top edge of the e-series pendant into the bumper as shown below



- 6) Fit the left/right sides
- 7) Pull the bottom of the bumper over the e-series pendant
- 8) Note: If your local safety requirements dictate unencumbered or direct access to the E-stop button, cut the protective rubber brow as your safety requirements dictate. Molded cut-lines are embossed around the E-Stop brow. A utility knife may be used to cut the Santoprene™
- 9) Power-up the controller
- 10) Installation is complete
