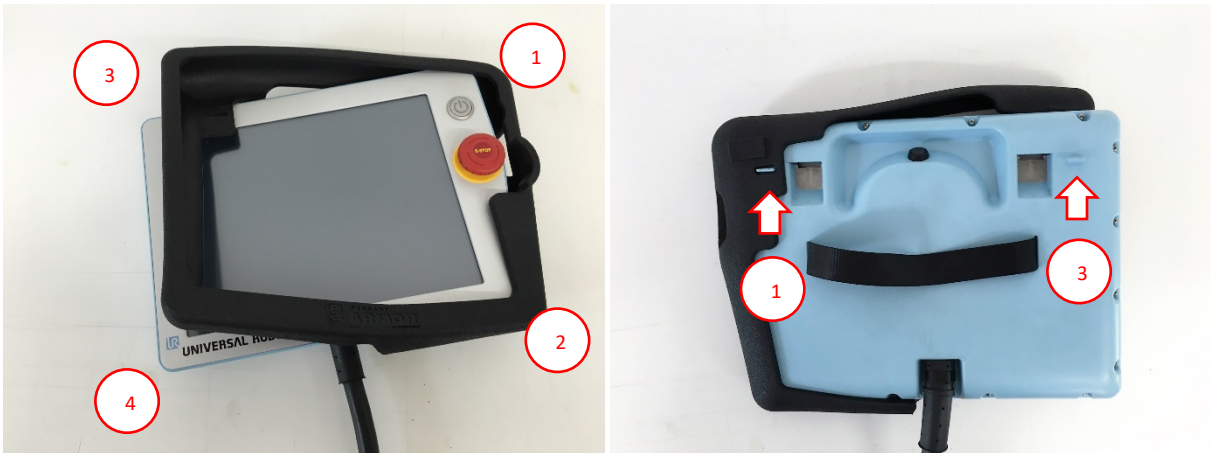


## Installation Instructions, Universal Robots CB-series Pendant Armor®:

- 1) Power-down the controller
- 2) Place the pendant face up on a clean, dry surface
- 3) Lay the bumper atop the pendant
- 4) Begin by inserting the top-right edge to the bumper. **1** *Note the engagement slots on the rear of the bumper fit into the tabs (feet) of the pendant*



- 5) Fit the bumper to the lower-right corner **2**
- 6) Once the right edge is secure, pull the bumper across the top-left corner of the pendant. **3**  
*Note the engagement slot on the rear of the bumper*
- 7) Pull the bumper over the lower-left corner **4**
- 8) Note: If your local safety requirements dictate unencumbered or direct access to the E-stop button, cut the protective rubber brow as your safety requirements dictate. Molded cut-lines are embossed around the E-Stop brow. A utility knife may be used to cut the Santoprene™
- 9) Power-up the controller
- 10) Installation is complete
